BACKGROUND AND CHANGES REQUESTED UNDER SECTION 78 OF THE *PLANNING ACT* 2016

The applicant proposes to amend the civil engineering design drawings to align with the recent Development Approval (council Ref: COM/2024/271) and further hydraulic analysis of the existing gully pit proposed for relocation as part of the heavy duty VXO installation which shows the bypass flow under a 100% blockage scenario of the 'V' grate within the heavy duty VXO can be suitably captured by the next downstream pit without having a detrimental impact on the D*V of the flooded width of the flow.

The civil works proposed as part of this Operational Works Application are consistent with City of Gold Coast's City Plan Land Development Guidelines and the SEQ Design and Construction Code.
